He explained his sons were police officers and expressed his worry that the overreaction of the press will cost even more lives. "Police officers get killed in the line of duty nearly every day and that is a tragedy. Some have suggested the solution is to defund, cut funding, reallocate funding, but that will accomplish nothing good," James said. "80% of the police funding goes into salaries. If we cut funding, we will lose many officers. If we lose officers, response times will go up, citizens will be underserved and unsafe. The primary responsibility of government is the safety of its people, all of its people."
